

APPRAISAL RECONSIDERATION FORM

The appraisal review/dispute process requires that <u>all desired revision requests</u> be made at the time of initial submission of this form. A one-time submission will optimize communication and allow for predictable turn times and ultimately, a timely resolution. The "review" process does not permit for A&D approaching the appraiser multiple times. A&D, unless an unusual circumstance exists, will approach the appraiser with the below concerns one time.

A&D requirements to facilitate a review are:

- All errors or omissions that you would like the appraiser to review or believe may necessitate a
 revision to the appraisal report must be clearly identified and supported by verifiable data. Any
 and all supporting information/data must be contained herein or attached to this document.
- If there is a difference of opinion between you and the appraiser regarding comparable sales contained within the appraisal report, full explanations must be given in the space provided. As referenced above, supporting evidence must be attached (if applicable). Any and all comparable sales provided for appraiser review must be closed sales.
- Closed sales should be the most recent and comparable sales available, with similar characteristics and marketability features as the subject.
- If you are requesting that the appraiser add commentary and/or provide an additional comparable sale or current listing to the appraisal report, reason(s) why must be clearly explained.
